Mr. Appel reviewed the Financial Statements. For March Mr. Appel stated TFT had restricted funds of \$369,315.15 with \$16,215.73 allocated to marketing, and \$4,000.00 in the Marci Hyman (Scholarship). In unrestricted funds they had donations of \$3,160.46. The bank balance for the month was \$434,329.22.

April – Restricted funds of \$394,079.40 with \$15,986.78 allocated to marketing, not a lot of movement from previous month, everything remained about the same. Their bank balance is \$434,329.22. (See Financial Statements).

Board Member Rosales made the motion to accept the financial statements, second by Board Member Garcia.

Mr. Miller stated The First Tee Tournament was a success, they raised over \$55,000.00. Bermuda Dunes is looking into changing the date for the event because it is going to fall on Valentine's Day. They are also looking for alternative venues to host the tournament, one being PGA West.
