# 3. Financial Report

Mr. Bonner reviewed the Financial Statements. For January Mr. Bonner stated TFT has the bulk of restricted funds \$368,227.24 with \$16,215.73 allocated to marketing, \$4,000.00 in the Marci Hyman (Scholarship). In unrestricted funds they have \$-119.69. Mr. Bonner asked Mr. Miller about the negative funds and Mr. Miller said it should be positive, a typing error.

February – This time of the year is when the foundation gets most of the donations from the tournaments. Expenditures - the \$75,000.00 is the transfer of funds to the DRD per agreement. Their bank balance is \$422,703.18. On the restricted funds not a lot of movement from previous month, everything remained about the same. (See Financial Statements).

# 5. <u>Updates and General Information:</u>

While they were waiting to do the financials Board Member McGalliard mentioned how DRD acquired TFT. The city of Palm Desert wanted for the District to do things for them, DRD traded a property that now is a church and in return they built the Recreation Center and the YMCA. The District runs those facilities at very little cost to the City of Palm Desert, also the District bought The Golf Center and started TFT of the Coachella Valley.

RAP – Mr. Miller stated some foundation board members, Kevin and himself met with a couple of representatives and the board of directors of RAP before the changes started to take place. The executive director is leaving and also Judee Cox. They talked about getting a grant writer / marketing person to help raise funds for the foundation and support DRD, the salary will be paid for two years by RAP.

Mr. Miller stated First Tee Month is about awareness and for people to know TFT is not just about golf but also about life skills. They have already raised over \$6,000.00 and have six more events going on during the month. They also created a list of things the golf courses can do to raise funds for TFT.

Mr. Miller reached out to the Berger Foundation for a grant for the furniture, they been very receptive since the money is not for operations. Ms. Lynn donated \$4,500.00 for Trips for Kids and is going to donate for the computer lab in the class rooms. TFT is doing very well, will be getting a grant from the USGA for \$11,500.00 and a donation from the Houston Foundation for \$25,000.00. This session they have over 400 kids participating. The Annenberg state wasn't

going to have their classes this year but changed their minds and now 14 youngsters are participating in an eight week session.

Mr. Kalman stated he was just coming from a meeting of the Board of Supervisors and the DRD master plan was approved, it has been approved by their board since December and now has their approval. The federal government gave verbal approval for the BMX Park and investors started to move forward. They are waiting for a response from the School District on the counter offer for the Oasis school. He also met with the California endowment and they are interested in helping with the funding of North Shore, somebody else is building it and DRD is taking over. They are interested in the health of the Coachella Valley. Indio is going thru renovation.

First Tee Building – Mr. Kalman stated the new building is ready and the old one has already been sold to a church.
